ASSOCIATE NON-VOTING MEMBERSHIP, WITHOUT VOTING RIGHTS, SUBJECT TO DUES SAME AS VOTING ACTIVE MEMBERS **

* FAMILY AND INDIVIDUAL MEMBERS ARE THOSE INDIVIDUALS OR ENTITIES THAT MEET THE DEFINITION OF AN "ACTIVE MEMBER" UNDER THE ASSOCIATION'S BYLAWS. AN ACTIVE MEMBER IS DEFINED AS A RESIDENT OF THE LAMORINDA AREA OWNING PROPERTY IN THE MUNICIPALITIES OF LAFAYETTE, MORAGA, ORINDA, OR THEIR ASSOCIATED UNINCORPORATED AREAS, AND WHO HAS WINE GRAPES PLANTED, OR IMPENDING PLANS TO PLANT WINE GRAPES, AND WHO ARE CURRENT IN PAYMENT OF ANNUAL MEMBERSHIP DUES. **ALL MEMBERSHIP DUES ARE RENEWED AT OR BEFORE THE JULY (2ND QTR) GENERAL MEETING.**

NOTE: GENERAL MEETINGS: MEMBERSHIP WIDE GENERAL MEETINGS ARE HELD 4 TIMES A YEAR, ONE EVERY QUARTER. UNLESS OTHERWISE NOTIFIED BY THE BOARD OF DIRECTORS, THE MEETINGS ARE REGULARLY SCHEDULED FOR THE FIRST MONTH OF EACH QUARTER, ON THE LAST SUNDAY OF THAT MONTH (I.E JANUARY, APRIL, JULY, AND OCTOBER). THE JULY GENERAL MEETING IS THE OFFICIAL BEGINNING OF THE FISCAL YEAR AND THE TIME WHEN MEMBERSHIPS ARE RENEWED AND WHEN ELECTIONS FOR OFFICE ON THE BOARD OF DIRECTORS ARE HELD.

** AFFILIATE MEMBERS ARE NON-QUALIFIED INDIVIDUALS OR ENTITIES, INTERESTED IN SUPPORTING AND PARTICIPATING IN THE ASSOCIATION'S GENERAL MEETINGS, EVENTS, AND ACTIVITIES. ALL ASSOCIATE MEMBERSHIPS MUST BE VOTED ON AND APPROVED BY THE BOARD OF DIRECTORS.
